Treat as per requirements for surrounding fires. Evacuate area and contact emergency services. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas. Polypropylene can ignite or melt at high temperatures.

10.3 Possibility of hazardous reactions

Aluminium oxide may cause the exothermic polymerization of ethylene oxide. May cause the vigorous polymerization of vinyl chloride.

10.4 Conditions to avoid

Avoid contact with incompatible substances.

10.5 Incompatible materials

Incompatible with chlorine trifluoride (reacts violently, forming flame) and ethylene oxide (polymerises violently). Dissolves slowly in alkaline solutions.

May evolve aluminium oxide when heated to decomposition.

Only at excessive concentrations of aluminium are toxic manifestations seen and, hence, aluminium is considered to possess a "low" potential for producing adverse effects.

No data available for aluminium oxide. Lung fibrosis has historically been associated with aluminium powder

exposure; however, this powder was coated with mineral oil, which is no longer done. Exposure to uncoated aluminium powder has not been associated with lung fibrosis.

Aspiration This product is a solid and aspiration hazards are not expected to occur.

12.1 Toxicity

The No Observed Effect Concentrations (NOEC) for aluminium oxide in testing of fish, invertebrate, and algae are all above 100mg/L.

12.2 Persistence and degradability

Product is persistent and would have a low degradability.

12.3 Bioaccumulative potential

This product is not expected to bioaccumulate.

12.4 Mobility in soil

A low mobility would be expected in a landfill situation.
